

1. Guidelines for Category #4 (Patriotism):

This is our signature project to honor all Texas Veterans. Once your package is received, it will be vetted and if approved, your profile will be entered to the Hall of Fame under Category #4. Upon approval your profile will be loaded to the website. A medallion or marker to placed on the gravesite is available to purchase. The medallion or marker will have a website listed on it and when the public is viewing the grave, the visitor can pull up the website and read about that Veteran's service and life story. Once the profile is loaded, the Veteran or his family members may have access to update the online profile.

- a. Must be have been discharged from the U.S. Military under honorable conditions. Must have been born in Texas or lived/served in Texas for at least 7 years.
- b. Mandatory documents:
 - i. Nomination Form.
 - ii. One copy of a **high definition photograph** of the Veteran. Other photos can be submitted. If so, they must be in a jpeg format and on a thumb drive.
 - iii. Discharge Orders.
- c. Suggested Items listed below to include in the nomination packet: (No limit on the pages of required and recommended documents.) Create a synopsis of the Veteran's accomplishments. Some suggested areas are provided below.
 - 1. Military Awards and Decorations. Refer to the list in paragraph 3b above and the Nominee's Discharge Orders.
 - 2. Civilian and military education.
 - 3. Professional employment history.
 - 4. Describe the Veteran's Advocacy Contributions and include the Nominee's active involvement with veterans' service or support organizations.
 - 5. Present the Nominee's civic affiliations and contributions (e.g. Rotary, Kiwanis, schools, public service, fraternal, etc.)
 - 6. Discuss civilian awards, honors, or publications about the Nominee: (e.g. Presidential awards, Who's Who, Citizen of the Year, books, newspaper or magazine articles, etc.)
 - 7. Summary of achievements: A chronological list by date of the veteran's achievements that were shown in the Discharge Orders and discussed in the above Synopsis.

8. Include "Narrative(s)" for the veteran's highest military medals(s) listed in the Discharge Orders and documents that verify the Nominee's military and civilian accomplishments that are listed in the Synopsis and the Summary.
